At least once every 12 months, the Authorized Body shall check the due functioning of the distributor's product inspection system pursuant to the provisions of Art. 5 (5) of the above-mentioned Government Regulation, take product samples, test the product samples and assess whether the product characteristics comply with the specified standard. The Authorized Body shall evaluate the surveillance and issue a report for the distributor.
